

Loss Prevention Plans for Underwriters & Brokers

Loss prevention is amongst the top priorities for any Maritime Underwriter. One critical loss prevention opportunity that has gone relatively unexploited is when terms are drafted and liabilities are apportioned: the drafting of the fixture note. No more: Unafix is an online, Al-based fixture drafting tool compiled by an LL.M. in maritime law that aids users in drafting unambiguous fixture notes. Loss prevention packages are available for Underwriters keen on offering high-tech loss prevention measures to their Members and Insured.

Unafix, short for unambiguously fixed, is what happens when you combine years of P&I claims handling experience with a team of passionate software developers. It is a browser based, artificial intelligence powered tool for ship owners, charterers and brokers that helps them draft unambiguous fixture notes. Unafix reduces contractual maritime disputes by increasing awareness of conflicting fixture clauses, ambiguous terms, and clauses that could jeopardize cover under insurance policies. We offer loss prevention packages for Underwriters and Insurance brokers. Underwriters and brokers may wish to participate in the future development of Unafix through the Active Development Program.

Here's how it works

Participating in Unafix' Loss Prevention program is simple and a great opportunity to present yourself towards your Members and Insured as an involved Underwriter that embraces high-tech means of loss prevention. We believe in progression through collaboration, which means that as a Loss Prevention Participant you'll be able to submit any feedback you have. Improving the tool together benefits your Members and Insured, and therefore ultimately you as well. In a nutshell, here's how we can team up to improve loss prevention .

1. Enrollment

Fill out the attached form to choose the loss prevention pack of choice. After receipt of a signed original copy, we'll have your account up and running within 7 calendar days. If you send us a scanned copy, we'll start making preparations immediately.

2. Discount codes

- Generation of discount codes

 Once your Underwriter account has been set up, you can generate discount codes to hand out to your Members and Insured. These discount codes are unique and can be used by a single one of your Members or Insured.
- Retraction of discount codes From your Underwriter account, you can retract discount codes, for instance when a Member or Insured terminates their policy with your association. This way, you are in full control of the number of discount codes that are in circulation at any given moment. There will be a seven calendar days period between your retraction of a discount code and the discount code actually being retracted. Unafix may, during this period or thereafter, inform the user in question of the retraction of the discount code and the effect this has on their billing.

3. Invoicing

If you have selected Loss Prevention Pack 2 or Loss Prevention Pack 3, i.e. packs that have Underwriter contribution, we will invoice you per e-mail for your contribution on a quarterly basis. The payment term of our invoice is four weeks. If a discount code has been used for anything but a full quarter, for instance if it is a new discount code or if it has been retracted, the Underwriter contribution will be calculated on pro-rata basis.

4. Upgrading, downgrading or terminating your Loss Prevention Pack

You can upgrade, downgrade or terminate your Loss Prevention Pack at any time with 1 month written notice to us. If you upgrade, downgrade or terminate your plan, invoices will be calculated on a pro-rata basis.

- Upgrading or downgrading your Loss Prevention Package
 If you upgrade or downgrade your Loss Prevention Package, existing discount
 codes will be upgraded or downgraded accordingly. Unafix may inform the users
 that are ffected by the upgrade or downgrade.
- Terminating your Loss Prevention Package
 If you terminate your Loss Prevention Package, all circulating discount codes will
 be retracted by us as of the 1st day of the second month following the day of
 receipt of your written notice. This means that if we receive your written notice on
 January 24, your account will be terminated on March 1st.

5. Additional benefits

- Active Development Program (ADP)
 You will have access to our ADP with any loss prevention plan, meaning that you can submit feedback and suggestions to improve the Unafix AI Engine. You may use this as much as you please, but are under no obligation to do so. Constant improvement of the AI engine through collaboration is the goal of our ADP.
- Use of your logo on Unafix
 In Loss Prevention Pack 2 your logo will circulate with other partners' logos on the Unafix home page. Available space for circulation depends on the number of partners and is therefore at Unafix' discretion.
 In Loss Prevention Pack 3 your logo will be permanently placed on the Unafix homepage, starting at the date of your account being activated until the date of termination or downgrade of your account. If you so request, the backend of the users using your discount codes will be branded with your logo as well.
- Underwriter accounts
 Unafix will make available Underwriter accounts free of charge to you. From here, you can use the Unafix Fixture Generator to assist your Member as required, and manage your discount codes.

6. General Terms and Condition
